ALOJAMIENTO

- *High Holborn Residence*: habitación individual superior, *self-catering*. Incluye desayuno continental. Es una de las residencias más modernas de LSE, localizada a solo 5 minutos de la universidad. Posibilidad de habitación *standard*, *large*, o doble, y de baño privado: consultar.
